1. Rating - Players can play any or all events as long as they meet rating requirements. The cutoff date for rating eligibility is 7/14/2025. We primarily use the USATT league rating for this tournament. Active USATT membership is not required. We may use player's tournament ratings if they do not have league ratings. Suppose a player has his tournament rating equal to or exceeding 250 points of his league rating. In that case, we will use his tournament rating to determine his eligibility. Players who do not have league or tournament ratings may participate in the tournament with an estimated rating provided by the organizer. We disallow former pro players from participating in this tournament. Tournament match results affect neither players' league nor tournament rating. The organizer reserves the right to decide on rating, eligibility, and tournament matters.
2. Play Format - Based on the number of entries, the teams will be divided into 4 to 8 groups. Each group will consist of 4 to 5 teams and play a group RR first, followed by single elimination. The teams will be placed in each group according to their seeding ratings on the entry deadline. Each RR group's top two finishing teams will play crossover single elimination to determine the final standings.
3. Captain - Each team designates a captain, who must have a WeChat ID and will join the captain's WeChat group to communicate the tournament issues. A captain is responsible for completing and submitting the entry form, including the team name, players' names and IDs, Indemnity Agreement Signatures by players with dates, and submitting players' entry fees. The entry will only be official after the entry fees are received. Please include the event you enter and your team name when paying the entry fees.
4. Others - We will use Butterfly tables and Nittaku 3-star premium 40+ white balls for the tournament. The club will be open by 9 am on tournament dates for players to warm up. Players will be defaulted on their matches if they do not show up 10 minutes after the match starts. We expect matches to be completed by 5 pm, but the exact finish time may depend on the number of entries and other factors.
